Candidates are required to come for Walk-in-interview with duly filled in application in prescribed format along with a recent passport size photograph, and bring all certificates in original and a set of self-attested photocopies of the same, in support of age, qualification and experience for verification. Incomplete application in any form will be rejected.

10. If the numbers of candidates are more, the walk-in-Interview may be continued on the next day.
