Eligibility :- Educational Institutes / Autonomous Bodies / R&D Institutes

Educational Institutes such as Schools/ Colleges / Universities / Polytechnics/ ITI's etc and R&D Institutions owned by Central / State / Local self Governments (Including their Autonomous bodies) shall be eligible for receiving the donation.

Terms and Conditions for the donation of the Surplus Printing Machine(s):-

1. Request for donation must be received from the Head of the Eligible Institutions/ Organizations, for Universities / NIT's/ Colleges Registrar or Deputy Director(Admin) may also submit for donation to Director.
2. **Delivery:-**
 - a. The stores shall be delivered on "AS IS WHERE IS AND WHAT IS BASIS". Delivery of the items kept at site from CSIR-NIScPR, PUSA Road, New Delhi 110012 has to be taken by the done / recipient institution.
 - b. The Stores should be lifted by the recipient Institution within the stipulated period intimated to them, by following the terms, conditions and the procedure for delivery as per donation letter issued by CSIR-NIScPR, New Delhi.

- c. The Printing Machines will be transferred on Book Value transfer Basis. The recipient / Donee Institute / University/College/ R&D Institute has also to give an undertaking to the effect that these Printing Machines will not be used for any Commercial Purpose.
 - d. The Cost of transportation ex-CSIR Lab./Instt. will be the responsibility of the recipient organization including All Charges towards movement, lifting, dismantling, packaging, installation, Insurance, freight incurred towards the said Printing machine(s) as per list from CSIR-NIScPR, New Delhi to the location of the Recipient Organization/ Institution .
 - e. Director, CSIR-NIScPR will reserve the right to cancel the offer of stores to the shortlisted institution, if delivery is not taken within the specified.
 - f. The Director CSIR-NIScPR may extend the delivery time, if a specific request is made to this effect by the Head of recipient organization.
 - g. The delivery of the Stores would also mean the transfer of ownership along with all concomitant risk and liabilities (statutory or otherwise) to the recipient organization
 - h. The Director CSIR-NIScPR may add any other delivery condition as it may consider relevant.
- 3. Statutory Compliances (Tax/ Safety/ FEMA etc.)**
- a. All donations of imported items shall comply with the provisions of FEMA/ Exchange Controller Manual (ECM) of RBI or any other guidelines that may be issued by RBI/ Government of India, State Govt of the respective state.
 - b. Taxes, Cesses and Duties, if any, applicable on such donations shall be realised from/ paid by the recipient Institution
 - c. Labs./Instts./CSIR Hqrs shall comply with all legal and regulatory compliances that may be applicable to each specific stores being donated. Special care shall be taken in respect of equipment having e-waste / hazardous material, Batteries/ lead acid batteries as well as vehicles, boilers and the like. Attention of the recipient Institutions must be drawn to the special legal & regulatory provisions that may be required to be complied by them upon receipt of such stores on donation
- 4. Acknowledgement/ Accounting/ Record keeping**
- a. It shall be ensured that the recipient Institution gives a formal acknowledgement of all the stores received.
 - b. As regards the accounting treatment of such donated stores, the same procedure is to be followed as is prescribed for disposals made under other permitted modes.

Komori Lithrone4 color Offset Printing machine is equipped with automatic control press console from which we can control the semi-automatic plate change, color control, color profile management, ink and water control, and other operational activities. The maximum paper size which can be printed on machine is 530x750mm and the minimum paper size which can be printed is 200x280mm, and the paper thickness can be printed from 0.04 to 0.3 mm.

The plate size of the Komori Lithrone four color offset printing machine is 605x760mm.

Blanket dimensions of Komori Lithrone four color offset printing machine is 678x770mm.

Maximum printing speed of Komori Lithrone four color offset printing machine is 16000 Sph and the minimum printing speed is 3000 Sph.

Komori Lithrone four color offset printing machine is equipped with Alcohol dampening system

Approximate weight of the Komori Lithrone four color offset printing machine is 15400 kg.
