On the assessment promotion, the pay of promotees will be fixed as per normal rules. However, they will have the option, except Sl. No. 7, to be exercised within one month from the date of issue of this order for fixation of pay in the promoted matrix/level with effect from the date of promotion or with effect from the date of increment in the present grade, in terms of the extent provisions of FR-22.

The promotees, except Sl. No. 7, will continue to perform the same duties as already assigned to them or to perform such other similar or higher duties as may be assigned to them from time to time.

The assessment is distinct from promotion under the DPC system and does not necessarily lead to change of work pattern or higher supervisory status or power though it does lead to an expectation of better performance. It does not imply higher perks in form of office space, telephone, stenographic assistance, furniture etc., which will continue to depend upon functional needs.
